Minute's approval:

Chief Acord presents the board with resolution 24-001 which details the pay per call reimbursement covering expenses for travel, clothing, etc. The payment per call is proposed at \$20 going up from \$15.

Commissioner Milliken makes a motion to accept resolution 24-001, Commissioner Lindsey seconds the motion and all are in favor.

Clarification by Chief Acord for the board about sick leave and annual leave.

Commissioner Milliken discusses the 58% training response rate for 2023. Milliken asks about the Commissioners role in helping. Commissioner Brandenburg states that in this day and age it's hard to get people to commit to training, and surprisingly it's as high as it is.
