## Additions to agenda:

#### **Old Business:**

Chief Acord reports that there were 3 applicants for the new Full-Time Secretary position; there will be interviews in the first week of April.

### **New Business:**

Chief Acord provides the commissioners with a copy of a grant application for Federal Assistance to Fire Fighters Grant (AFG Grant). Total cost of the grant application is \$228,699.95.

Chief Acord provides details on WAC codes with regards to fire gear. NFPA 10 year rule starts in the 2008 edition. Currently we're subject to the 1991 edition of the WAC.

The District took some classes and seminars on this particular grant, and Chief Acord and Assistant Chief Stamps feel confident about this year's application.

**Rating Bureau Update:** 

Chief Acord reports on this years WSRB rating, and states that there was positive news. Rating went from an 8 to a 7, if there is a permanent water source it stayed at a 6.

Chief Acord presents some of the deficient findings, including 24 hour coverage, Volunteer training hours, etc.
